## Show & Stay Giveaway 2024 (the "Contest")

THIS CONTEST IS OPEN ONLY TO CANADIAN RESIDENTS WHO ARE AT LEAST 18 YEARS OF AGE OR OLDER. NO PURCHASE NECESSARY.

## 1. Contest Sponsor(s):
